Visit Findings

- i. All the offered programs have the required HEC NOC.
- ii. HEC Post Graduate Policy 2023 has been implemented with effect from Fall 2023 and its final approval is on the agenda of the next academic council meeting.
- iii. All HEC policies for MS and PhD programs are being implemented.
- iv. Various program related documentation was reviewed and found satisfactory.

- v. Feedback from MS and PhD students was satisfactory. However, some students raised the concern about availability of wifi and availability of High-Performance Computing resources. Some students requested that access to IEEE journals be made available in the library.
- vi. PhD Notifications should include complete journal information about the paper publication along with its relevant category as per HEC.
- vii. Course folders of MS and PhD Courses should be maintained.
- viii. Thesis credit hours should be mentioned on the transcript of the student.
- ix. An effort should be made to ensure that the PhD Publication is in the relevant journal to the degree program and the word "relevant" should be incorporated in the PhD rules.
- x. Graduate admission test policy must be in adherence to the 2023 HEC policy for MS and PhD Programs.
- xi. Applicants must be asked to provide a PhD research proposal at the time of PhD admission.
- xii. Student files of MS/PhD students be complete with all the relevant notifications.
- xiii. Core courses should be defined for MS/PhD Electrical and Mechanical Engineering Program.
- xiv. PhD progress performa should be revised so that one to two pages.
- xv. The university should establish a Directorate of Research in line with HEC guidelines responsible for all the activities related to MS and PhD students.
